REDEVELOPMENT

Those owners that have answered the Solicitor's inquiry have received their RFQ/P. The first package returned for review has been from LaMartinique Bowling. The borough auditing firm is reviewing the financial information which should be completed in time for action to appoint the owner as the redeveloper for their parcels located in Area 1.

REPORT #3:

ABC

The Ordinance for ABC licenses has been adopted. The first license proposed is for Redevelopment Area 1. The initial resolution draft was presented to council. As was discussed at the last meeting, council was to review the draft and decide on some of the information that is required to complete the resolution in order to adopt it at our June 09

meeting. The main piece of information required is the minimum bid price for the license.

REPORT #4: REPEAL SHADE TREE CHAPTER 2.48
Councilman Grover and Santoro have reviewed the information given by the State Department of Forestry, NJDEP. The draft ordinance will be ready to hand out at the Agenda Meeting for review, and action to take place at the June 09 meeting.
