Res.2010:50 Resolution 2010:50 –Seek Tax Relief from State of NJ for Kennedy Hosp. and UMDNJ
 On motion of Councilman M. Santoro, seconded by Councilman F. Gagliardi with all ayes on the vote.

RESOLUTION 2010:50

WHEREAS, the Borough of Stratford is approximately 1.6 square miles in area; and
WHEREAS, the Borough of Stratford’s total property tax assessment is \$400,391,509.; and
WHEREAS, the Borough of Stratford is host to an array of tax-exempt properties; and
WHEREAS, the Borough of Stratford’s tax-exempt properties make up 28.43% of the total borough assessment or \$113,997,700.; and
WHEREAS, the two biggest tax-exempt properties are the Kennedy Health System Hospital complex and the University of Medicine and Dentistry of New Jersey facility; and
WHEREAS, the UMDNJ has a direct working and teaching relationship with the Kennedy Hospital; and
WHEREAS, the Kennedy Hospital represents 8.5% of the total assessment of the Borough of Stratford or \$34,026,600.; and
WHEREAS, the UMDNJ represents 14.38% of the total assessment of the Borough of Stratford or \$57,665,800.; and
WHEREAS, the Kennedy Hospital and UMDNJ represent 80% of the tax-exempt properties in the Borough of Stratford; and
WHEREAS, if these two entities were paying annual taxes, Kennedy would pay \$1,809,194. and the UMDNJ would pay \$3,066,091.; and

WHEREAS, the remaining taxpayers of the Borough of Stratford must bear the burden of these tax-exempt properties; and

WHEREAS, the Borough of Stratford is overburdened by being the host municipality to these two large tax-exempt monopolies,

NOW, THEREFORE, BE IT RESOLVED, by Mayor and Council to seek relief from the State of New Jersey to assist the Borough of Stratford in this unfair tax burden; and

FURTHERMORE, to authorize Assemblymen Fuentes and Wilson to act on our behalf to seek any assistance and aid from the NJ Department of Community Affairs, which may be available to the taxpayers of the Borough of Stratford, to include seeking qualification for distressed municipal funds.
