ORDINANCE AMENDING CHAPTER 10.44 ENTITLED
TRAFFIC SCHEDULES**

THE BOROUGH COUNCIL OF STRATFORD DOES ORDAIN
WHEREAS, THE BOROUGH OF STRATFORD has determined that amending the Ordinance is in the best interest of the health, safety and welfare of the Borough and its residents;

NOW, THEREFORE, BE IT ORDAINED by the Municipal Council of THE BOROUGH OF STRATFORD that:

Section 1. Section 10.44.040 Schedule IV – Permit parking only. Add the following to the table:

Block 12, Lot 2,	Wright Avenue	Along the curbline of the residential
Block 15, Lot 5, 6, 7		properties listed.

Section 2. Repealer.

All ordinances or part of ordinances inconsistent or in conflict with this Ordinance are hereby repealed as to said inconsistencies and conflicts.

Section 3. Severability.

If any section, part of any section, or clause or phrase of this Ordinance is for any reason held to be invalid or unconstitutional, such decision shall not affect the remaining provisions of this Ordinance, and each section and subsection thereof, irrespective of the fact that any one or more of the subsections, sentences, clauses or phrases may be declared unconstitutional or invalid.

Section 4. Effective Dates.

This Ordinance shall take effect immediately upon passage and publication according to law.
