#### PUBLIC PORTION FOR AGENDA ITEMS ONLY:

Gilligan motioned to open the public portion on agenda items only. Hall seconded the motion, which passed with all members present voting in favor in a voice vote.

Adrian Costado, Whitman Ave. spoke about her organization CSTAR and their request to use the senior center for their clinics. There were no further questions or comments.

Hartman motioned to close the public portion for agenda items. Lomanno seconded the motion, which passed with all members present voting in favor in a voice vote.

POLICE REPORT: - Chief Morello gave his report as follows:

# COUNCIL REPORT MAY 2018

- During the afternoon hours, we were called to the Bradlees shopping center for a report of a strong armed robbery that allegedly occurred in the wooded area between Rowan & Bradlees. A drunk vagrant wanted to report that two large men robbed him of his sneakers as he sat near a small pond back in the woods. Our best Detectives arrived at the scene and within minutes located the stolen property. No large men, Just Two large ducks made off with the drunks sneakers and tore them apart in the center of the pond. The good officers then went to Goodwill to secure the man a replacement pair of shoes.

  Not so much Goodwill, for the needy as the Officers paid \$25.00 to replace the gentlemen shoes.
- During the morning hours, we were called to an apartment to check on the wellbeing of a tenant. 45-year-old female was found dead because of a suicide by hanging. Female who was apparently upset over some legal issues hung herself with an extension cord, second from a second floor landing into the stairwell.
- Our freshly ordained Animal Cruelty officer secured a voluntary surrender of a vicious pitfall from a home on Cornell. Just an FYI, a voluntary surrender of a vicious dog (IN NOT BIKE CASE) saves weeks of rangling. In order to take a dog in non-bite cases, there must be a summons, a court appearance, a conviction and a judicial order to seize the animal. This case worked out much easier.
- 5/6 During the evening we responded to Pennsylvania Avenue 20 year old female who had overdoses. Narcan was deployed to revive the female. Again.
- Officer Butler made a very nice drug arrest after a car stop on Berlin Road.
  He seized about 40 bags of crack cocaine, \$1000.00 in cash and a 2004
  Cadillac Eldorado from a Lindenwold drug dealer. After all that, the risk assessment software released the arrestee without incarceration.
- 5/12 During the evening, we were called to the Alpine court regarding a child who had been burned with hot bath water. In this case the parent was bathing the toddler, and mom left the room for just a moment or two. The toddler had managed to turn the cold water off ... as the tub filled.... The child was taken to the hospital for some low grade burns on his bottom. Thankfully, the child was treated and released.

- During the afternoon hours we were called to the CVS for a report of a fight (just after picking up a shoplifter same location. Mayor said hello to that suspect on our bench) As it turns out a road rage turned into an Aggravated Assault after the victim was electrocuted by another motorist with a Stun Guns. These devices were recently made legal to carry IN NJ, however not necessarily legal to use. The suspect eluded capture.
- 5/16 During the morning, the FD and PD responded to a dwelling fire on Buttonwood Road (Councilwomen Hall may have a suggestion in that regard)
- 5/17 Another overdose, this time a 50 year old female from the 100 block of Princeton. A double dose brought her back.
- 5/25 During the overnight hours we were called to the Stratford Laundry Mat for a burglary in progress. Two 18 year old has from Camden had forced open the rear service door in
- An officer was injured by scratches and blood borne exposure while assisting Hi-Nella PD with a drug addict who had burglarized several apartments in Fox Ridge. While chasing the suspect, he ran thru a slider window into an apartment and the bad guy sustained serious cuts to both calves. A struggle ensued and our officer was seriously contaminated by the suspect's blood. As a result, he was treated at the hospital and is taking some heavy-duty anti-Viral meds. A workers comp claim is underway with no lost time from work.

No issues to report at the JP2 carnival, they had a good week.

The final class for the 2018 DARE program was a success with the US Army / landing their drug interdiction helicopter at Yellin School, the children really enjoyed it, as did Councilwomen.

We established an two annual scholarships funded by the PBA in the name of the Stratford Police Department. Awarded to a male and female graduate from Stratford demonstrated by an 8th grade student demonstrating honesty, honor and integrity as chosen by the school district.

### FY 2018 NJDOT Municipal Aid Funding - Sunnybrook Road and Sunnybrook Court

#### Update:

A preconstruction meeting was held on Monday, June 4, 2018, at the Borough Municipal Building between Arawak Paving, our office, Stratford Police Chief, Ben Angeli, and a representative of the Stratford Arms Apartments. The Notice to Proceed is anticipated to be issued for the week of June 25, 2018.

#### Previously Reported:

- Our office has submitted for a NJDOT FY 2018 Municipal Aid application for the improvements of Sunnybrook Road and Sunnybrook Court. A resolution for authorization for our office to submit application was passed at the September Council Meeting.
- Application (MA-2018-Resurfacing of Sunnybrook Road & Sun-00413) including the
  cost estimate, location map, and scope of work description to reflect up to date unit
  costs was submitted on October 6, 2017 and three (3) certified resolutions were
  forwarded to NJDOT Local Aid.
- Improvements for these roadways include milling the existing roadway 2" deep with isolated areas of base repair as needed. The entire roadway will be overlaid with 2" Hot Mix Asphalt 9.5M64 Surface Course. Existing concrete curb, driveway aprons, and handicap ramps will be replaced, as needed.
- The Borough has been informed by the NJDOT that it will be receiving \$270,000 for construction and inspection of this project. The Borough is moving forward with this project and is supplementing the NJDOT grant award with \$84,220 from the 2017 Borough Bond. Our office has submitted a April 4, 2018 correspondence delineating the costs for the required inspection and construction management. Our office anticipates construction for spring / summer of 2018.
- The project was publicly advertised for bids.
- The bid opening for this project was held on April 25, 2018. Six (6) bids were received with Arawak Paving Co. with the low bid in the amount of \$221,000.00 for the Base Bid and Add Alternate Bid #1.

# FY 2018 Road Program - Resurfacing of South Winding Way (STRAT2018-1)

#### Update:

- Our office has completed the survey of and anticipates public bid and construction for late summer of 2018.
- It the understanding of our office the Borough is considering reallocating the remaining funds (\$84,220) from the 2017 Borough Bond towards this project. It is noted that the \$84,220 was previously allocated to the Sunnybrook Road and Sunnybrook Court project.
- Our office has submitted a May 8, 2018 correspondence delineating the costs of the required survey, design, and inspection / construction management (see attached) for included the resurfacing of a section of Coolidge Avenue with this project.
- Our office met with New Jersey American Water (NJAW) regarding pavement restoration repairs along Winding Way from Longwood Drive to Green Valley Road and Winding Way from Hillside Road to Longwood Drive (inclusive of this project limits). We will continue to coordinate with NJAW regarding a solution pavement restoration for all NJAW trenched areas of Winding Way.

#### Previously Reported:

- The Borough is moving forward with this project and has allocated \$250,000 for the roadway improvements.
- Our office has submitted an April 4, 2018 correspondence delineating the costs of the required survey, design, and inspection / construction management.

# CDBG 2018 Program Year Application – Resurfacing of Hunt Avenue and Bishop Terrace (STRAT2018-0)

#### Previously Reported:

- The Community Development Block Grant (CDBG) program has notified participating Camden County municipalities of new allocation procedures which include funding projects of larger scale (as high as \$250,000). In addition, not all municipalities will be allocated each year (estimated at 5 to 7 projects).
- The Borough of Stratford has two (2) areas consisting of Qualified Census Tracts.

## **ENGINEER'S STATUS REPORT Borough of Stratford** June 2018

- Both Hunt Ave and Bishop Terrace are on the Borough's 2018 road priority listing and are within the Borough's Qualified Census Tracts. Therefore, our office recommended applying to the CDBG program for \$225,900 to resurface these roadways. It is noted that the Borough would be responsible to fund approximately \$7,500 of design costs if successful in obtaining the grant.
- Our office submitted application to CDBG for this project on April 13, 2018.

(3) Matters Involving Individual Privacy: Any material the disclosure of which constitutes an unwarranted invasion of individual privacy such as any records, data, reports, recommendations, or other personal material of any educational, training, social service, medical, health, custodial, child protection, rehabilitation, legal defense, welfare, housing, relocation, insurance and similar program or institution operated by a public body pertaining to any specific individual admitted to or served by such institution or program, including, but not limited to information relative to the individual's personal and family circumstances, and any material pertaining to admission, discharge, treatment, progress or condition of any individual, unless the individual concerned (or, in the case of a minor or incompetent, his guardian) shall request in writing that the same be disclosed publicly.
