ORDINANCE 2018:13

CREATING A KNOX BOX "RAPID ENTRY SYSTEM" IN THE BOROUGH OF STRATFORD

This is the first reading and introduction, the public hearing for this ordinance will be on December 11, 2018 at 7:00.

ORDINANCE 2018:13

CREATING A KNOX BOX "RAPID ENTRY SYSTEM" IN THE BOROUGH OF STRATFORD

BE IT ORDAINED by the Borough Council of the Borough of Stratford as follows:

Section 1: Purpose

The following subsection requiring the installation of a Knox Box "Rapid Entry System" on new construction structures as noted below, and to establish installation requirements and compliance as determined by the Stratford Fire Chief and Stratford Code Official.

Experience has shown when fires occur in buildings, the Fire Department must make entry into the structure, locate, confine, control and extinguishment the fire. Further, fires within buildings are not always readily evident from the outside when the fire department arrives. Delaying fire department entry into a building can and will allow a fire to grow and make the fire more dangerous. When evidence of a fire is noted from the outside, forcible entry into a building is time consuming and represents a delay in locating and extinguishing the fire. In order to expedite entry into a structure and to aid the Fire Department in the task of extinguishment, the installation of a Knox Box "Rapid Entry System" shall be required on new construction structures and highly recommended on existing businesses as noted below.

Section 2: Definitions

AUTOMATIC DIALER: a device that automatically dials and/or relays a prerecorded message to a central station or the Fire Department.

AUTOMATIC FIRE SUPRESSION SYSTEM: a system or assembly of piping, valves, controls and sprinklers which are designed and installed to comply with the NFPA standards, which utilized water, foam, CO2 or other as to automatically react to suppress fire.

CENTRAL STATION: an office of a private company which remote alarm and supervisory signaling devices are transmitted and where personnel are in attendance at all times to supervise the circuits and investigate signals.

FIRE ALARM SYSTEM: equipment which automatically actuates a fire decrease in temperature or activation or a sprinkler system or manually activated device.

LOCK BOX: a high security key vault which is under the UL 1610 and the UL 1037 standards, master keyed with a Medeco Biaxial Level 7 or equivalent lock. Locks shall be keyed to the key configuration provided by the Stratford Fire Department.

Section 3. Requirement

- A. The owner or person in control of the following types of buildings shall install and maintain a Rapid Entry Key Box of a type approved by the Stratford Fire Chief and Stratford Code Official prior to the issuance of a certificate of occupancy:
 - i. All newly constructed buildings within the Borough of Stratford, having automatic alarm system, dialer, Central Station or equipped with an automatic fire suppression system except one and two family owner-occupied dwellings.
 - ii. New constructed Multi-family residential structures, including senior citizen apartment/condo complexes that have restricted access through locked doors and have a common corridor for access to the living units.
 - iii. New constructed Commercial and industrial buildings identified by the Stratford Fire Chief as difficult to access during emergencies.
 - iv. All new constructed high rise buildings, i.e. structures having floors at or above fifty (50) feet above ground level.
- B. The owner or occupant of any existing business or structure who decides to install a Rapid Entry Key Box shall be required to comply with the terms of this Ordinance.

Section 4. Exemptions

The following structures are exempt from the mandate to install the Rapid Entry Knox Box System:

- i. Single family structures and multi-family structures that do not meet the requirements set forth in Section 3 above.
- ii. Structures that are staffed 24 hours a day, 365 days a year (which may include but are not limited to nursing homes, hospitals, police stations, fire stations etc.)

- iii. Structures that have 24 hour, 365 day on site security staff or personnel on site
- iv. Schools whether public or private

Section 5. Key Box Location:

- A. The Key Box, shall be of a UL type, and approved by the Stratford Fire Chief and Stratford Code Official. The Key Box shall be installed, at or near the recognized public entrance, adjacent to the fire alarm panel, on the exterior of the structure or in a location or locations designated and approved by the Stratford Fire Chief.
- B. The box shall be located at a height approved by the Stratford Fire Chief and Stratford Code Official of not less than four (4) feet and not more than ten (10) feet above the final grade. The Key Box is not required to be attached to or monitored by the alarm system, however, this action is recommended. The Knox Box does come equipped with the option to connect to the alarm monitoring system.

Section 6. Knox Box Contents

Any Knox Box installed pursuant to this Ordinance shall contain the following:

- i. Keys/fobs to locked points of access/egress, whether interior or exterior of such buildings.
- ii. Keys/fobs to all locked rooms and/or panels, including but not limited to mechanical, electrical, sprinkler and alarms.
- iii. Keys to locked elevator rooms and elevator controls.
- iv. Keys/fobs to any fenced or otherwise physically secured area.
- v. Keys/fobs to any other areas, as determined necessary and appropriate, by the Stratford Fire Chief.
- vi. Emergency information card, containing the name(s) and telephone number(s) of emergency contacts for such buildings.

Section 7. Compliance:

The Fire Sub-code Official shall be responsible for compliance with the section requirements, for all buildings currently under plan review for future construction.

The property owner shall immediately notify the Stratford Fire Chief or his designee and provide the new key(s) when a lock is changed or rekeyed. The updated key shall then be secured in the Knox Box.

Section 8. Penalties:

Penalties for non-compliance by any building owner, in violation of the provisions of this section, shall be subject to a penalty being assessed after receiving notice by the Stratford Fire Chief and Stratford Code Official.

Section 9. Inconsistency

All ordinances and provisions thereof inconsistent with the provisions of this Ordinance shall be and are hereby repealed to the extent of such inconsistency.

Section 10. Invalidity

If any section, subsection or part, clause or phrase of this Ordinance shall be declared invalid by judgment of any court of competent jurisdiction, all other parts or provisions of this Ordinance shall be considered severable and deemed lawful and enforceable.

Section 11. Effective Date

This Ordinance shall take effect immediately after final passage and publication as required by law.

WHEREAS, on or after January 1, 2007, the Law prohibits a municipality from awarding contracts with a value in excess of \$17,500. to a business entity that makes certain reportable contributions one year prior to the contract; and

WHEREAS, the contractor can be awarded a contract even though he may have reportable contributions, if the award is made through a "fair and open" process; and

WHEREAS, to be "fair and open" the contract should be advertised to give notice in advance of the contract, and publicly opened and announced when awarded; and

WHEREAS, the minimum requirements of a "fair and open" process are:

Publicly advertised with sufficient time of 10 calendar days to give notice, and Awarded under a process that provides for public solicitation of proposals, and Established on the basis of an award and disclosure process documented in writing prior to any solicitation, and

WHEREAS, the notice should include:

A description of the requested goods or services;

The time, date, and place proposals must be submitted;

Contract information for obtaining the proposal document;

The name of the agency requesting the proposal; and

A statement that the proposal is being solicited through fair and open process in accordance with N.J.S.A. 19:44A-20.5 et seq.

WHEREAS, there are several alternatives in choosing their basis for award under a fair and open process such as:

Choosing the lowest responsible bidder as in traditional bidding

The standard used by both state government and the competitive contracting model

"most advantageous price and other factors considered".

Other fair and open process established by the agency

WHEREAS, the bids do not have to be opened and awarded at the same time, do not have to be opened at a public meeting, and can be awarded at a separate time by resolution by the Governing Body with wording stating to a "fair and open" process or a "non-fair and open process"; and

NOW, THEREFORE, BE IT RESOLVED by Mayor and Council to authorize the Borough Clerk to advertise to receive proposals for the 2019 year under the "fair and open process" of the pay-to-play law, and have resolutions to awards ready for the Governing Body's Reorganization Meeting to be held on January 2, 2019 for the following services:

Councilwoman Hall thanked Mr. Collins for his words and wished everyone a safe and happy Holiday. She also congratulated Mr. Green and Mr. Hartman for being reelected.

Councilwoman Lomanno read a letter from a Mrs. White thanking the police officers that were at her accident site and wanted to say how professional and considerate they were. She did not get the officers names, but it was Officer Rebecca and Officer Camburn. She wanted to thank the Chief for the success in getting the RSO approved for the schools. She stated that the students and staff will feel more safe and secure with the officer in the buildings. She thanked Ms. Hall for the Halloween parade and stated that she thought that the cornstalks and bows on the poles really seemed to be a great way to kick the season off. She thanked the chief and the code enforcement officer for dealing with a resident's problems with a neighbor. She stated that she wanted to clarify her comments from the agenda meeting concerning the code enforcement official position. She said that she felt that it would be more organized to appoint all the officials at the same time rather that in different months.
