ORDINANCE 2019:14 AN ORDINANCE OF THE BOROUGH OF STRATFORD, COUNTY OF CAMDEN, STATE OF NEW JERSEY AUTHORIZING A FINANCIAL AGREEMENT PURSUANT TO THE FIVE-YEAR EXEMPTION AND ABATEMENT LAW

WHEREAS, the Local Redevelopment and Housing Law, <u>N.J.S.A.</u> 40A:12A-1, <u>et seq</u>., as amended and supplemented (the "Redevelopment Law"), provides a process for municipalities to participate in the redevelopment and improvement of areas in need of redevelopment or rehabilitation; and

WHEREAS, on March 3, 2011, the Borough Council adopted Resolution 2011-32 designating parcels identified as Block 116, Lot(s) 14 and 14.04 (the "Property" or "Rehabilitation Area") as an "Area in Need of Rehabilitation" in accordance with the Redevelopment Law, referred to herein as the "Rehabilitation Area;" and

WHEREAS, pursuant to Ordinance 2011:05 adopted on August 9, 2011, the Borough Council adopted a redevelopment plan entitled "Laurel Mills Redevelopment/Rehabilitation Plan" which was subsequently amended by Ordinance 2014:02 adopted on February 11, 2014, further amended by Ordinance 2017:11 adopted on July 11, 2017, and further amended by Ordinance 2018:03 adopted on April 10, 2018 (the "Redevelopment Plan"), which sets forth, *inter alia*, the plans for the redevelopment and rehabilitation of the Rehabilitation Area; and

WHEREAS, the provisions of the Five-Year Tax Exemption and Abatement Law, <u>N.J.S.A</u> 40A:21-1, <u>et</u> <u>seq</u>. (the "Exemption Law"), permit a municipality to exempt from the payment of real estate taxes, for a limited period of time, any improvements made in the development of a rehabilitation area, subject to the terms and conditions of a tax agreement complying with the requirements of the Exemption Law; and

WHEREAS, Laurel Mills, LLC, a New Jersey Limited Liability Company having offices at 15 Wilkinson Avenue, Jersey City, New Jersey 07305 (the "Entity"), has taken title to the Property and submitted a proposal to the Borough to construct a mixed-use project consisting of a 14,000 square foot retail building and related improvements (the "Commercial Improvements") and a for-sale residential townhome community consisting of eighty (80) units, including sixteen (16) affordable housing units and related improvements (the "Commercial Improvements" and "Residential Improvements" being collectively identified as the "Project" or "Project Improvements"); and

WHEREAS, the Entity, which is qualified to do business under the Exemption Law, has submitted a formal request to the Borough for a five-year tax exemption on the Residential Improvements to the Property pursuant to the Exemption Law; and

WHEREAS, the Borough approves the tax exemption requested by the Entity subject to the terms and conditions of a Financial Agreement, and the parties desire to set forth in detail their mutual rights and obligations with respect to the tax exemption applicable to the Residential Improvements; and

WHEREAS, the Entity and the Borough wish to enter into a Financial Agreement with respect to completion of the Residential Improvements to the Property; and

WHEREAS, the Mayor and Borough Council find that the relevant benefits of the rehabilitation and completion of the Residential Improvements on the Property outweigh the loss, if any, of property tax revenue in granting the tax exemption and that it is in the best interest of the residents of the Borough to enter into a Financial Agreement between the Borough and the Entity.

NOW, THEREFORE, BE IT ORDAINED by the Borough of Stratford, County of Camden, and State of New Jersey as follows:

<u>Section 1</u>. The aforementioned recitals are incorporated herein as though fully set forth at length.

Section 2. The Mayor or Borough Administrator and Borough Clerk are hereby authorized to execute a Financial Agreement, pursuant to the Exemption Law, between the Borough and Laurel Mills, LLC for completion of the Residential Improvements of the Project on property identified as Block 116, Lot(s) 14 and 14.04 on the Official Tax Maps of the Borough of Stratford.

Section 3. All Ordinances or parts of ordinances inconsistent with this Ordinance are hereby repealed to the extent of such inconsistency.

<u>Section 4</u>. This Ordinance shall take effect after final adoption and publication according to law.

ORDINANCE 2019:16

AN ORDINANCE OF THE BOROUGH OF STRATFORD, COUNTY OF CAMDEN, AND STATE OF NEW JERSEY, AMENDING CHAPTER 8.56, ENTITLED "BOARD OF HEALTH REGULATIONS," OF THE CODE OF THE BOROUGH OF STRATFORD

WHEREAS, Article 3, entitled "Smoke Control," of Chapter 8.56, entitled "Board of Health Regulations," of the Code of the Borough of Stratford adopts a code regulating the emission of smoke from fuelburning equipment, internal-combustion engines, open fires, stacks or chimneys, and provides for the inspection of fuel-burning equipment, pursuant to the Public Health and Sanitation Codes Adoption by Reference Act; and

WHEREAS, upon recommendation of the Borough Fire Chief, Chapter 8.56 has been determined by the Mayor and Borough Council of the Borough of Stratford to be in need of revision and modification to include additional safety regulations pertaining to open burning within the Borough; and

WHEREAS, pursuant to N.J.S.A. 40:48-2 the Mayor and Borough Council may make, amend, repeal and enforce such other ordinances, regulations, rules and by-laws not contrary to the laws of this state or of the United States, as it may deem necessary and proper for the good government, order and protection of persons and property, and for the preservation of the public health, safety and welfare of the Borough and its inhabitants; and

WHEREAS, the Mayor and Borough Council deem it in the best interest of public health, safety and welfare of the residents of the Borough to amend Article 3 of Chapter 8.56 to include the additional safety regulations recommended by the Borough Fire Chief pertaining to open burning within the Borough.

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Council of the Borough of Stratford that the Code of the Borough of Stratford is hereby amended, revised and/or supplemented as follows:

SECTION 1. Article 3, entitled "Smoke Control," of Chapter 8.56, entitled "Board of Health Regulations," of the Code of the Borough of Stratford is hereby amended, modified and/or supplemented to read as follows:

"Article 3 - Smoke Control

8.56.090 - Acceptance of standards.

A. A code regulating the emission of smoke from fuel-burning equipment, internal-combustion engines, open fires, stacks or chimneys, and providing for the inspection of fuel-burning equipment, is established pursuant to the Public Health and Sanitation Codes Adoption by Reference Act (L. 1950, Chapter 188). A copy of said code is annexed hereto and made a part hereof without the inclusion of the text thereof herein.

B. Stratford Borough hereby further adopts the following regulations concerning open burning within Borough limits as follows:

1. Definitions.

(a) "Open burning" the kindling of a fire in the open air without containment or in outdoor structures that permit products of combustion to be emitted directly into the ambient air space, excluding gas or charcoal grill barbecues.

(b) "Approved outdoor structures" noncombustible containers which include but may not be limited to outdoor fireplaces, fire pits, receptacles, chimeneas, patio warmers, portable woodburning devices or other devices which meet the minimum standards set forth in this article that permit products of combustion to be emitted directly into the ambient air without passing through a stack or chimney from an enclosed chamber and which do not provide effective control of the air pollutants generated and are used for outdoor recreation and/or heating.

2. Regulations. Open burning shall be permitted in approved outdoor structures subject to the following requirements:

(a) Open burning shall be conducted 25 feet from dwelling (15 feet if in approved outdoor structure with spark arrestor);

(b) Open burning shall be conducted 25 feet from any structure, combustible exterior wall, or other combustibles that may ignite and permit the spread of a fire. Examples include but are not limited to shrubs, trees, fences, wood piles, leaf piles, etc. (15 feet if in approved outdoor structure with spark arrestor);

(c) While open burning is being conducted, it shall be attended by a competent person of at least 18 years of age at all times until fully extinguished;

(d) Any person conducting open burning shall have at least one (1) form of extinguishment or fire-suppression readily available;

(e) No person shall cause an open fire or outdoor fire to be used or maintained in such a manner as to cause a nuisance to neighbors; and

(f) The Code Enforcement Officer or police officer may order an outdoor burning activity to cease if conditions are such or the activity is so situated as to endanger the health or safety of persons or property located in the general area of the activity. If the party responsible for outdoor burning activity does not immediately comply with an order to cease given pursuant to this subsection, the party responsible shall be subject to the penalties set forth below. Any open fire or open burning or use of a chimenea, outdoor fireplace, or fire pit which creates a nuisance or is deemed to be a hazard is to be extinguished.

8.56.100 - Title. [No Changes.]

8.56.110 - Copies on file. [No Changes.]

8.56.120 - Violations and penalties. [No Changes.]"

SECTION 2. Except as set forth in Section 1 above, the balance of the Code of the Borough of Stratford shall not be affected by this Ordinance.

SECTION 3. All Ordinances contrary to the provisions of this Ordinance are hereby repealed to the extent that they are inconsistent herewith.

SECTION 4. If the provisions of any section, subsection, paragraph, subdivision, or clause of this Ordinance shall be judged invalid by a court of competent jurisdiction, such order of judgment shall not affect or invalidate the remainder of any section, subsection, paragraph, subdivision, or clause of this Ordinance.

SECTION 5. This Ordinance shall take effect immediately upon posting, publication, final passage in the manner prescribed by law.
