## **GOOD AND WELFARE:**

Councilman Gandy motioned to open the meeting to the public for Good and Welfare. Councilman Tolomeo seconded the motion, which passed with all members present voting in favor in a voice vote.

John Gentless – 111 Union Avenue – Mr. Gentless asked if Longwood Drive from Warwick Road had been paved recently but was opened. Mr. Keenan stated it was paved by the utility company and there is a moratorium on street openings. Mr. Keenan stated he would look into the matter. Mr. Gentless stated he heard Rowan University will be creating a student parking area on property it owns along the White Horse Pike and connected to campus via a walkway. Mr. Gentless asked if the Borough should ask for more money from Rowan to compensate the Borough for the loss of a ratable. Mr. Gentless asked when Council would resume in-person meetings. Mr. Keenan stated there is no date set at this time.

Mr. Gentless asked what was going on at the Atlantic Avenue substation. Mr. Keenan stated Atlantic City Electric was performing a complete upgrade to the station. Mr. Keenan stated the project would take another year. Mr. Gentless asked if there would be any further ribbon cuttings scheduled. Councilwoman Hall sated the Borough has offered to hold ribbon cuttings and its up to the individual businesses to decide if and when to hold one. Mr. Gentless asked if the Borough is anticipating receiving any additional CARES Act funding. Mr. Gentless stated the money could be used to cover COVID expenses or help local businesses with the leftover going into surplus. Mr. Keenan stated the CARES Act funding cannot go into surplus and cannot be used for tax reductions. Mr. Keenan stated the funding can only be use for certain specific purposes. Mr. Keenan stated the Borough redevelopment efforts in 2022 will be funded with CARES Act funding. Mr. Gentless asked how the Berlin Road Redevelopment project began. Mr. Keenan stated the new study area was based on a recommendation by a subcommittee of Council. Mr. Keenan sated it is the next block along Berlin Road, adjacent to the previous area. Mr. Gentless stated the Borough made mistakes in adopting a resolution to refer the area to the Planning Board for a redevelopment study. Mr. Gentless stated the CARES Act funding would be better spent in the area of the former Incollingo's shopper market instead of the area proposed along Berlin Road. Mr. Gentless said in this day and age you have a white engineering firm is going to make a decision to condemn a piece of property with a business owned by a black lady down on Arlington Avenue he can't comprehend that. Mr. Keenan stated Mr. Gentless is the first person he's heard who has brought up the topic of race when discussing the Borough's redevelopment efforts. Mr. Keenan stated that Mr. Gentless may hold this opinion. Mr. Gentless said opinions are like bellybuttons, everyone has one. Mr. Gentless wished everyone a Merry Christmas and a happy and healthy New Year.
