### **PUBLIC PORTION FOR AGENDA ITEMS ONLY:**

Councilman Gilligan motioned to open the public portion on agenda items only. Councilman Gandy seconded the motion, which passed with all members present voting in favor in a voice vote.

John Gentless of 10 Union Avenue asked what was being amended in Ordinance 2021-12. Mr. Keenan stated the Ordinance clarifies that the front yard setback is measured from the property line.

Mr. Gentless asked are the appropriations authorized by Ordinance 2021-13. Mr. Keenan stated it will fund body worn cameras for Stratford Police, property improvements, Public Works equipment, fire equipment, police vehicles and road reconstruction and drainage projects.

Mr. Gentless asked what businesses would be impacted by the change in Ordinance 2021-14. Mr. Keenan stated the ordinance gives an exemption for restaurants with drive through service and convenience stores at gas stations.

Mr. Gentless asked if there would be additional public comment portions on the budget at future meetings. Mr. Keenan stated there are no requirements to have further public hearings on the budget but the public can comment on the budget at any future meeting when it is on the agenda.

There were no further comments.

Councilwoman Hall motioned to close the public portion for agenda items. Councilman Tolomeo seconded the motion, which passed with all members present voting in favor in a voice vote.

## **POLICE REPORT:**

Chief of Police Ronald Morello provided the following information:

May 3 a patron reported a stolen ring at the Stratford Diner. Unfortunately, the ring was thrown
out when the table was cleaned and not recovered.

- May 5 the department assisted the Somerdale Police Department with the report of an armed robbery. Chief Morello stated a "ghost" gun with a 30-round-capacity magazine was recovered from the suspect who was apprehended by Borough officers.
- May 6 a department vehicle was destroyed by an allegedly distracted teenaged driver. Chief stated the driver was charged with careless driving and the department is working with the insurance company to get the 15-year-old vehicle replaced.
- May 8 a 50-year-old drug addict was arrested at the Jefferson Hospital emergency room after allegedly threatening to kill members of the staff and charged with making terroristic threats.
- May 12 a resident of Atlantic Avenue escaped injuries after the vehicle they were working on slipped off its jack and pinned them underneath. Ch 26:30
- May 15 a 50-year-old-resident died of natural causes.
- May 17, Narcan save 30-year-old-man from Pine Hill at Burger King.
- May 18 a traffic stop resulted in a 25-year-old Lindenwold man being charge with possession of pills and heroin with the intent to distribute.
- May 19-25 Two residents had their identities stolen and Unemployment benefits were applied for in their names. Chief said there is no connection between the two victims and it appears to be part of a larger scam occurring throughout the country. Police are investigating.
- May 28 after a review an application for a Massage Parlor was denied due to the proposed location in a residential zone.
- May 28 body-worn-cameras have arrived for testing and training and will be implemented department wide soon.
- Municipal Court will begin limit in-person sessions. Capacity is limited to 6-8 defendants in the courtroom at any one time. Zoom court will continue
- PBA 30 and the Police Department are sponsoring two scholarships for graduating students from Yellin School.

### **ENGINEER REPORT:**

Mr. Bach stated his written report was submitted to Council. Mr. Bach stated FY2022 NJDOT Municipal Aid Grants are due July 1. Mr. Bach stated the Borough will submit for Central and Kirkwood avenues phase 2 for DOT funding.

## **COUNCIL COMMENTS**:

Council President Hall stated organizations are registering for the 4<sup>th</sup> July Parade and registration forms are on the website. Councilwoman Hall thanks the Public Works Department, Miss Stratford and Little Miss Stratford for helping to prepare and decorate the Memorial Park for the holiday. Councilwoman Hall also thanks the VFW for its spontaneous event they held on Memorial Day.

Councilman Gandy thanked the Police, Fire, Ambulance and OEM staff for the wonderful jobs they do. Councilman Gandy stated it was an honor to attend the Fire Department Annual Dinner and it was a nice event. Councilman Gandy also thanked the residents for their patience during the pandemic.

Councilman Gilligan thanked Chief Morello for securing a \$55,026.00 grant for body-worn-cameras which covers about half of the cost. Councilman Gilligan stated the first Friday in June is the Nation Gun Violence Awareness Day. Councilman Gilligan read a proclamation declaring Friday June 4, 2021 as National Gun Violence Awareness Day in the Borough of Stratford. Councilman Gilligan stated he wants to form a committee to discuss the implementation of a Social Media presence for the Borough. Council expressed its support for forming the Committee and placing a resolution on the June 8 meeting to create it.

Councilwoman Lomanno congratulated Chief Morello for securing the grant.

Councilman Tolomeo thanks everyone in the office for being patient and keeping operations running efficiently during the pandemic and at Public Works for keeping storm drains clear during recent storms. Councilman Tolomeo stated he wants to create a Cannabis Committee to study the potential pros and cons related to recreational cannabis legalization. Council expressed support for forming the Committee and placing a resolution on the June 8 meeting to create it.

Councilman Kelly stated it is refreshing to see Tim Hortons and Freebyrd Chicken projects progress and both will be nice additions to the Borough. Councilman Kelly thanks the Fire Department and Ambulance Service for their continued efforts to protect the public. Councilman Kelly stated it's the second month in a row that a member of the Police Department stepped up to protect the public and he thanked Sgt. Gagliardi for his efforts.

### **GOOD AND WELFARE:**

Motion was made by Councilman Gandy, seconded by Councilwoman Hall to open the meeting to the public for Good and Welfare with all Council voting aye.

John Gentless of 10 Union Avenue asked the Engineer what the scoop of the work on Central Avenue. Mr. Bach stated the Borough will apply for NJ DOT grant to Cooper to Whitman base bid Whitman to Wright under and alternate option. Mr. Bach stated they do not have further details on what improvements will be included beyond resurfacing of the roadway.

Mr. Gentless asked if sidewalks would be placed along Kirkwood Avenue. Mr. Bach stated the design work is not yet done. Mr. Bach stated the NJDOT does not require sidewalk installations where none currently exist.
