A motion was made by Councilman Pat Gilligan, seconded by Council President Linda Hall for the name of James Kelly to fill the vacancy of former Councilman Green's term which expires December 31, 2021. All Council voted aye by roll call vote. The Acting Borough Administrator administered the Oath of Office to Councilman James Kelly. He then was able to participate in the remainder of the meeting.

## **PUBLIC PORTION FOR AGENDA ITEMS ONLY:**

Gandy motioned to open the public portion on agenda items only. Hall seconded the motion, which passed with all members present voting in favor in a voice vote.

John Gentless of Union Avenue inquired to Council not accepting Councilman Green's resignation. The Solicitor Mr. Platt stated no acceptance or confirmation was required.

Tolomeo motioned to close the public portion for agenda items. Lomanno seconded the motion, which passed with all members present voting in favor in a voice vote.

#### **POLICE REPORT:**

Chief of Police Ronald Morello informed the public about a female at Brookview Manor around 3:00 am reported to have slit her wrist. The police located her in the rear of the apartment complex of Cornell Manor and took her to the hospital. There have been three attempts at the CVS which have resulted in arrests for several hundred dollars of items being stolen. A person wanted for sex crimes was found in Coolidge Park. On the morning of February 18, it was snowing, and a driver at the Warwick and Longwood fell asleep at the wheel of his car. Another driver tried to assist in getting into the car, but it was locked.

The other person broke open the window which startled the driver, and the driver sped down Longwood Drive at a high rate of speed. The driver ended up crashing into a tree. The driver was from Blackwood and was arrested for driving under the influence and taken to Cooper Hospital, and the dog in the car was taken to the animal orphanage. Drug dealing involving a 35-year-old Voorhees resulted in the man being arrested with 20 bags with the intent to distribute. He reported the day dedicated to collect unwanted medicines resulted in 25 pounds of medicines being collected. A grant for \$60,000. For Highway Traffic is being applied for. No update on the body cam for the State mandate. As of June 1, all patrolmen will have been trained for the body cam equipment. He spoke about the decriminalization of marijuana and alcohol which now will no longer be an issue, and the police cannot inform the parents of underage children who are seen or found with it on the first offense. On the second offense the police can tell the parents. He spoke about the municipality having the ability to place zoning regulations to restrict dispensary locations or to opt out of the program. The JLUB will be reviewing this issue and reporting back to Council.

## **ENGINEER REPORT:**

Mr. Bach reported his firm will be making the annual application for CDBG funding to the County. It will be the same as last year for funding for ADA improvements at the municipal offices and to reimburse the town for funding spent in advance for the Coolidge Avenue Road Improvements. He stated Homestead Road funding request was made to NJDOT to include design costs. The work has begun for Homestead and Evergreen Roads. Evergreen Phase 1 is finalized and all documents have been closed out. A resolution including a change order will be on for approval at the Tuesday meeting. The punch list items for the Coolidge Project are being addressed this week and close out documents will be submitted soon.

John Gentless of Union Avenue spoke about a pot hole on West Atlantic Avenue near the border of Hi-Nella. The Acting Borough Administrator stated he was aware of it. Mr. Gentless inquired of the Engineer if the sewer reports had been issued for Berlin Road Project and/or Warwick Road. Mr. Bach responded the sewer updates for both Berlin Road and Laurel Mills were issued. The report for Berlin Road requires some minor upgrades with a cost of about \$25,000.

Mike Mancini of Winding Way Road inquired to the marijuana regulations. The Solicitor stated the municipality could adopt regulations to permit or prohibit which starts with ordinances from Mayor and Council. He did note the JLUB could review and advise the Mayor and Council. The Solicitor stated he would reach out to the JLUB Solicitor to review this with him.

Tom Speer of College Circle inquired to the exposure if silent related to the marijuana regulations. The Solicitor stated there is an understanding during the 180-day period which is considered safe harbor.

Motion was made by Councilwoman Hall, seconded by Councilman Gilligan to close the meeting to the public with all Council to vote aye.

## **EXECUTIVE SESSION:**

Motion was made by Councilman Gandy, seconded by Councilwoman Lomanno, with all Council voting aye to enter into Executive Session.
