POLICE REPORT:

Chief of Police Ronald Morello informed the public about an unconscious female on Curtis Avenue and Officer Romeo revived the person and was transported to Jefferson and will survive. At Alpine Court Apartments a medical assist call for a 28-year-old male who had overdosed and the officers used two Narcan and then transported to Jefferson and made a full recovery. A burglary at Cornell Manor Apartments where a 25-year-old Hi Nella man was arrested. There was a dispute at Cornell Manor Apartments where a person was threatened with a knife, the officer convinced the person to drop the knife. A 12-year-old was struck by a vehicle on the White Hose Pike and the child made a full recovery. There were no charges filed against the driver. Another child on his bike, darted out in front of a vehicle in front of Yellin School and was hit around 5pm and not seriously hurt with no charges against the driver. There were four consecutive nights where the gazebo at Veterans' Park was vandalized with no one caught. The gazebo has since been repaired. There was a call from Camden County for mutual aid to Waterford where over 1000 vehicles had converged in that area and later onto Route 73 in Berlin near Walmart. 100 officers had responded. No injuries but damage to the building. A call for a 57-year-old female unresponsive was received, the son was administering CPR but she was deceased. A public notice was made by eblast related to the new upcoming body cameras mandated by the State.

He also stated they inspected the complaint from a resident related to the center road seam opening up on Winding Way Road which they concluded there was nothing concerning since no separation in the roadway.
